

Job Description: Part-Time High School Head Cheerleading Coach

Qualifications:

- A Four-Year College Degree OR Serving as an Approved Assistant Coach (3.1.4.b) (non-Hardship Coach) for a minimum of TWO school years.
- A Professional Teacher's Certificate OR NFHS Fundamentals of Coaching Course (online) passed prior to coaching. This course is not sport-specific. This is a one-time requirement.
- Successful completion of a Sports First Aid course prior to coaching and renewed every two years. (See options in Diagram 3.1)
- Successful completion of CPR/AED training prior to coaching and renewed every two years. (See options in Diagram 3.1)
- Background Check including Sex-Offender's Registry Clearance prior to coaching.
- Board of Education or Board of Governance Approval prior to coaching.
- Successful completion of a Concussion in Sports Course, and review of current concussion information yearly.
- Successful completion of the MSHSAA Sport-Specific Online Rules Review each season.
- Minimum of 3 years coaching experience preferred.
- Minimum of 3 years coaching or dance teaching experience preferred.

Reports to:

- Athletic Director
- Vice Principal

Terms of Employment: Appointed annually for the term of the season.

Essential Job Skills:

- Comprehensive knowledge of basic Cheer techniques and rules of the sporting game that cheerleaders are cheering at.

- Choreograph half-time performance routines. Make arrangements for audio during games and edit music as needed.
- Create chants and cheers. Call which cheers/chants to do at games.
- Maintain current CPR/AED and First Aid certification.
- Complete all trainings to comply with MSHSAA requirements.
- Provide emergency first aid.
- Create and support a positive, inclusive, and safe environment.
- Maintain, issue, and provide accurate inventory of uniforms and pom-poms.
- Develop positive relations with students and parents. This includes proper dress, language, demeanor, and student/teacher relations.
- To screen student athletes for membership on a team. Where cuts are required because of size limitations, proper judgment must be present to assess skills, aptitude, interest, and future ability and temperament.
- Provide eligibility lists, rosters, and other paperwork as required by administration.
- To be active in building participation, conditioning, and training through camps and individual contacts.
- Supervise student athletes before and after sporting events and practices.
- Ensure transportation has been scheduled with the Athletic Director for games and practices.
